10.1 Operations Division-Deputy Chief, Frank Drayton Operations Report of monthly activities

EMS Battalion Chief Duggan stated that the District responded to approximately 610 medical incidents and that EMS refresher training was held with Station 37 Personnel.

Acting Deputy Chief Aguiar highlighted the annual maintenance inspections that have taken place with irrigation systems repairs ongoing.
