1. CALL TO ORDER

President Stamey called the meeting to order at 10:10 a.m.

2. PLEDGE OF ALLEGIANCE

Director Lee led the Pledge of Allegiance.

3. <u>DETERMINATION OF QUORUM AND CONFIRMATION OF AGENDA</u>

President Stamey declared a quorum of the Board was present; and there were no changes to the Agenda.

4. PUBLIC COMMENT

There was no public comment.

5. NEW BUSINESS

Award of construction contract for the Public Safety Building project to Roebbelen Contracting, Inc. and authorize the Fire Chief to execute a final contract with Roebbelen Contracting, Inc.

Finance Consultant Campo informed the Board that there were four responsive bids submitted to the District. Based on the RFP selection criteria, evaluation and feedback from references, the District determined Roebbelen Contracting, Inc. (Roebbelen) was the lowest, responsive bidder with a bid of \$22,141,000. Financial Consultant Campo further informed the Board that the protest period has ended and there were no protests. Mr. Kjome of Roebbelen introduced himself and replied to Director Lee's concern about securing subcontractors by assuring the Board that the Public Contracts Code has strict

requirements for subcontractors and that indemnifications will be secured. Financial Consultant Campo emphasized that appropriate bonds and solid contract language will be negotiated to protect the District. Mr. Kjome responded to President Stamey's inquiry regarding the national direction for infrastructure by informing the Board that the California Public Contracts Code Section 4104 promissory estoppel language will ensure subcontractor performance. President Stamey recognized the District's work on the Public Safety Building project, including securing the lowest, responsive bidder.

Motion by Director Parker to award the construction contract for the Public Safety Building project to Roebbelen Contracting, Inc., consistent with their bid and the provisions contained in the RFP and that the Board authorize the Fire Chief to execute a final contract with Roebbelen Contracting, Inc., in substantial form as the draft contract attached to the staff report; seconded by Director Gallinatti. Motion carried unanimously by roll call vote.
